

HOMs Enrichment Partner Agreement

1. Purpose

This Agreement establishes a partnership between Helper of Mothers LLC (“HOMs”) and the Enrichment Partner to support homeschool families by recognizing the Enrichment Partner's programs as eligible enrichment activities within the HOMs network and directory that families may document within the HOMs Web App. The purpose of the partnership is to help homeschool families discover enrichment opportunities towards their HOMs App portfolio, promote programs to increase commerce, and establish HOMs App relevance through cross marketing affiliation.

2. Nature of Relationship

Both parties remain independent businesses. This Agreement **does not create**:

- employment
- agency
- joint venture
- franchise relationship
- educational authority
- school affiliation

The Enrichment Partner is not affiliated with HOMs as a school, and HOMs does not supervise, manage, certify, control, or guarantee the Enrichment Partner's programming, staff, safety procedures, pricing, scheduling, curriculum, or educational outcomes.

3. Enrichment Recognition

The Enrichment Partner's activities may be recognized by HOMs as homeschool enrichment activities that families may choose to log in the HOMs Web App. Examples may include, but are not limited to:

- Dance, martial arts, fitness, sports, or other forms of physical education programs
- Music, theatre, performance, or private lesson programs
- Art, crafts, design, or creative programs
- Foreign language programs
- STEM, robotics, coding, math, or science programs
- Ecological science, environmental science, nature, farm, or outdoor education programs
- Field trips, workshops, co-op classes, homeschool days, faith related studies or other approved enrichment opportunities

These activities may be categorized within HOMs core subject areas, including but not limited to Health & PE, Art, Music & Theatre Arts, Life Skills, Science, Mathematics, Social Studies / History, Foreign Language, Faith-Studies, Planning Materials, or other HOMs-recognized categories.

4. Promotion

HOMs may:

- List the provider as a "HOMs Enrichment Partner"
- Recommend the provider to HOMs families
- Include the provider in HOMs directories, website listings, app listings, social media, emails, flyers, or other promotional materials
- Share the provider's homeschool-friendly programs with families looking for enrichment opportunities

The Enrichment Partner agrees to:

- Display and describe "HOMs Enrichment Partner" recognition as a way for homeschool families to document the partner's "homeschool friendly" program through the HOMs Web App
- Share HOMs information with interested homeschool families
- **Add a link to the HOMs main website, HOMsApp.com, on the partner's website** in any area where the partner markets homeschool programs, homeschool-friendly classes, homeschool days, or homeschool enrichment opportunities
- If the partner displays a HOMs logo, badge, image, photo, or other HOMs-related graphic on its website, the image should, where technically feasible, **link directly to HOMsApp.com or be accompanied by a clearly visible link to HOMsApp.com**
- Promote HOMs special discounts or offers, if available, for families using the HOMs Web App for homeschool record keeping

The Enrichment Partner may not state or imply that HOMs certifies, licenses, accredits, supervises, legally approves, or guarantees the Enrichment Partner's program unless HOMs provides written approval of that exact language.

5. Curriculum Documentation

Participation in the Enrichment Partner's program may be recorded within the HOMs Web App for homeschool documentation purposes. HOMs may allow families to log:

- program name
- subject category
- subtopics
- participation dates and frequency
- class location and schedule when applicable
- instructor name when applicable
- notes, attendance, receipts, certificates, and other learning evidence

Both HOMs and The Enrichment Partner are not responsible for maintaining homeschool compliance records for families unless the partner separately agrees to do so outside of this Agreement. **Parents remain legally responsible for their homeschool program**, documentation, portfolio, instruction, accreditation confirmation, educational outcomes and compliance with applicable law.

6. Optional Partner Benefits

The Enrichment Partner may voluntarily offer benefits to HOMs families, including but not limited to:

- homeschool class times
- homeschool program days
- discounts for HOMs families
- special workshops, camps, trial classes, or family events
- program descriptions, photos, schedules, or flyers for HOMs to share with families

Any discounts, offers, schedules, or program benefits are controlled by the Enrichment Partner unless otherwise agreed in writing.

7. Termination

Either party may terminate this Agreement at any time with written notice.

Upon termination:

- HOMs may remove the partner from HOMs directories, listings, promotional materials, and app or website references
- The Enrichment Partner must stop using HOMs branding, partnership badges, logos, promotional language, and any statement implying an active HOMs partnership

Termination does not affect obligations related to confidentiality, brand use, or accurate public statements.

8. Changes to the Agreement

This Agreement may be updated or modified only by HOMs at any time. HOMs may update brand guidelines, approved language, promotional materials, or directory requirements from time to time for quality assurance and may provide updated instructions to the Enrichment Partner.

9. Signature

By signing below, the parties acknowledge that they have read, understood, and agree to the terms of this HOMs Enrichment Partner Agreement.
